

Privacy policy

We at KudurruStone are committed to respecting and protecting your privacy. We have developed this Privacy policy (the "Privacy policy") to help you understand what personal information about you we collect, use and share, and how you can correct or change such information. This Privacy policy applies to anyone who visits, browses or otherwise uses the Website, or who otherwise contacts us by mail, email, social media or telephone in connection with the Services we offer (collectively, "you").

This Privacy policy should be read along with our Terms of Service. Capitalized terms, if not defined in this Privacy policy, are defined in the Terms of Service.

1. Age of consent.

Our Services are not indented for Users younger than 18. We do not knowingly collect any information from children under the age of 13. In the case it comes to our attention that the information collected belongs to a child, that information will immediately be removed. 2. Information we collect.

2.1. Depending on your use of our Services, we may collect information you provide by creating an Account: your name, email address, company information, location.

2.1.1. If you are creating an Account as a Primary user, you will provide us: name of the Primary User, your company name, telephone number, legal physical address, city, state, bank account information.

2.1.2. If you are using our Services as an Authorized user by the Primary user (administrators, basic users or similar), you will provide us your name.

2.2. Payment Information – we may collect details of any requests or transactions you make through our Services. All payment information you submit is collected and used by our payment processors in accordance with their privacy policies.

2.3. We may also collect personal information from you as a result of your email, social media or telephone communications with us.

3. How we use collected information.

We use the information you gave us or that we collected: to provide you with the information and Services that you request from us; to identify you and authenticate your Account, to communicate with you and notify you about changes to our Service; to process payments - we rely on third parties to process debit and credit cards so we must share your payment information with third parties; to administer our site and for internal operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes; to improve our Services; as part of our efforts to keep our site safe and secure; to verify activity as we deem necessary; to respond to your inquiries, requests and complaints.

4. Where we store the collected information

4.1. All the Personal data will be securely stored on our server, with only a limited number of our employees having access to them.

4.2. We will delete all the personal data stored for the purposes of providing Services:

- a) If User asks to opt-out from our Services, we will delete all the personal data of a concrete User;
- b) After termination of these Terms.

5. How we share collected information.

5.1. We do not sell your personal information to third parties. We do not share your personal information except for the purposes of providing our Services, and only in the ways that are described in this Privacy policy.

5.2. We may share your Personal information as required by law: in response to lawful requests by public authorities, including to meet national security or law enforcement requirements, such as to comply with reporting requirements, a subpoena, or similar legal process; in connection with an investigation of fraud, intellectual property infringement, piracy, or other unlawful activity or as we believe reasonably necessary to protect or enforce our rights, protect your safety or the safety of others.

6. Third party links.

If you follow a link to any such website, please note that these websites have their own privacy policies and that we do not accept any responsibility or liability for these policies. Please check these policies before you submit any personal data to these websites.

7. Compromise of Personal Information

We will promptly notify you if your personal information becomes compromised. We do not accept liability for any unintentional disclosure or a disclosure that occurs due to a security breach of our systems or facilities.
